The Instructor/Lifeguard Subsidy Program (ILSP) provides training courses at a subsidized rate (up to 90% for each course) to select individuals from low-income households who are in financial hardship to pursue a career or a position as an Instructor/Lifeguard.

To determine eligibility for this program, the ILSP application form evaluates applicants' financial status and interest and capacity to successfully complete Instructor/Lifeguard training courses.

To Apply

Review the Eligibility Requirements to ensure that you are eligible to apply and complete the application fully with all supporting documents attached.

Eligibility Requirements

You may qualify, if you meet all of the following requirements:

- · You are a Richmond resident.
- You are 13 years of age or older (legal guardians need to complete the ILSP application for those 18 years old and under).
- You are able to swim 400m continuously using recognizable swimming strokes.
- You are able to complete a swim assessment, if required.
- You are motivated and committed to complete Instructor/Lifeguard Training courses.
- You exemplify interest in a career or position in aquatics.
- You are in financial hardship and either A or B applies:
 - A. You receive **one** of the following government financial assistance:
 - Youth Agreement or Agreements with Young Adults (AYA).
 - Income Assistance or Disability Assistance from MSDPR.
 - Resettlement Assistance.
 - BC Housing Rental Assistance Program (RAP) or Shelter Aid for Elderly Renters (SAFER).
 - Guaranteed Income Supplement (GIS).
 - B. Your annual net income(s) for the tax year 2023 do not exceed these threshold(s):
