I, the applicant, agree to waive, remise, release, indemnify and save harmless the City and the City's officials, officers, employees and agents from and against all claims, demands, losses, costs (including legal costs), damages, actions, suits, or proceedings whatsoever brought by reason of, or arising from, the issuance of a Permit by the City or the proposed Underpinning Works or Construction Fence by or on behalf of the applicant.

I, the applicant, agree to release the City and the City's officials, officers, employees and agents from any losses the applicant and/or the applicant's officers, directors, employees, agents, contractors, subcontractors, licensees, permittees and/or visitors may sustain relating in whole or in part to the construction, repair, use, replacement or removal of the underpinning works or construction fence.

The terms and conditions of these indemnity and release provisions shall survive the removal of the underpinning works or construction fence.

I, the applicant, acknowledges and agrees that by signing this application, I am agreeing that if a permit is issued by the City regarding the subject matter of the application, that the application, all required documentation and the permit shall collectively constitute an agreement between the applicant and the City for the applicant to construct and use the proposed underpinning works or construction fence in accordance with this application, the *Underpinning Works and Construction Fence Encroachment Bylaw No. 9833*, all required documentation and the permit.
