
Purpose of OCP Designation Amendment:

To amend a series of maps and one plan in Schedule 2.10 (City Centre Area Plan) to relocate one North-South "Minor Green Link" east of Cooney Road further east along Kwantlen Ave.

Purpose of Zoning Amendment:

To rezone the north eastern portion of the subject property from "Auto-Oriented Commercial (CA)" zone to the new "Residential/Limited Commercial (ZMU55)" zone and "School and Institutional Use (SI)" zone, to permit development of mixed use and residential uses on three parcels.
